- A \$100 damage deposit (refundable) is due at the time of booking for weddings. After the event, the deposit will be refunded by mail within thirty (30) days providing no damages have been incurred.
- Victoria Hall has a max capacity of 71 persons as issued by the Fire Marshall.
- All rental arrangements for the use of Victoria Hall shall be made through the Facilities Manager at 506-459-1611 or <a href="mailto:nancy.stcroix@vonm.ca">nancy.stcroix@vonm.ca</a>
- Users must complete the rental agreement and pay in full the established fees prior to the rental and at the time of key pick up. If paying by cheque, payment must be received at least 10 days prior to the rental date.
- Payment is accepted by cash, cheque or debit and is to be paid at the Village Office.
- The Village of New Maryland does not provide on-site staff during rentals.
- Only persons nineteen (19) years of age or older may rent Victoria Hall.

## **Alcohol Policy & Special Occasion Permit**

- Users must obtain a "Special Occasion Permit" through the Dept. of Public Safety for any function requiring liquor and post the permit in the hall during the rental period.
- The application form must be signed by the Facility Manager prior to applying for the permit.
- A signed application form can be emailed to you or provided by the Facility Manager upon request.
- Please bring a copy of the permit with you when you pick up the key.
- The renter is solely responsible for ensuring all stipulations are followed as listed in the permit application submitted to the provincial government.

#### **Décor Policy**

- When decorating, the following is NOT permitted:
  - Tape (scotch, packing, duct) mac tac, poster putty, nails, push pins or tacks of any kind.
     Painter's tape or masking tape is acceptable.
  - o **ABSOLUTELY NO CONFETTI** in or around the building or parking lot. This includes hand held streamer "poppers".
  - ABSOLUTELY NO TABLE GLITTER OR SPARKLES used inside the hall.
  - Only battery-operated candles are permitted to be used.
- Decorations and any equipment used during your event must be removed by completion of your rental period. Please ensure time is allowed for this before rental period ends. Anything left behind for later pick up must have prior approval from the Facilities Manager

## Victoria Hall Rental Application/ Agreement

### **Smoking Policy**

- Smoking is strictly prohibited anywhere in Victoria Hall.
- As per the "Smoke Free Places Act", smoking is not permitted within 9 metres (30ft) of doorways.

#### **Noise Policy**

- Under the Village by-law No.55-2000, which provides guidelines for the control and prohibition of noise:
  - No person shall make or cause, or permit to be made or caused, any noise or continuous sound which disturbs or tends to disturb the quiet, peace, rest, enjoyment, comfort or convenience of persons in the vicinity.
- All functions at Victoria Hall must end by 1am.
- Fireworks are not permitted.

#### **Damages**

• The client is responsible for any damages incurred to Victoria Hall during their rental period.

## **Loss of Rental Privileges**

- Repercussions for failing to adhere to the Victoria Hall rental agreement include:
  - o Future scheduled time(s) will be revoked for the use by the group(s) in question.
  - Cost for repairs or damages done to Victoria Hall will be billed to the group, individual, association or organization for payment.
  - Future rental agreements will be denied until all outstanding bills are paid in full.

#### **Cancellation Policy with a Damage Deposit.**

- In the event that inclement weather forces cancellation of an event, a full refund will be issued.
- A full refund of the damage deposit, less a \$25 processing fee, is refunded if the request is more than one month (30 days) from the event.
- All cancellations received less than thirty (30) days from the rental date will result in the forfeit of the damage deposit.
- All refunds will be returned by cheque via mail within thirty (30) days of cancellation date.

#### **Automated External Defibrillator / EPI-PENS**

- Victoria Hall has a public accessible AED located in the main hall. An AED may help improve
  the survival rate of sudden cardiac arrest.
- In the event of a sudden, life threatening, allergic reaction, adult and child EPI-PENS are located inside the AED cabinet.
